Delays in the Supplier's Performance: Delivery of the Goods and performance of related Services shall be made by the Supplier in accordance with the time schedule prescribed by the Purchaser in the Purchase Orders. - b) Service tax GST shall be payable extra as applicable to the pick-up vehicle against their bills on submission of a copy of valid G.S.T. registration certificate and Income Tax PAN.
- c) Under normal circumstances, the contract shall be valid for a period of **one year** from date of issue of work order. Rahuri Semen Station is at liberty to place the contract for period less than above period without assigning any reason. The

Either party to the contract can terminate the contract by giving **07** days' notice in writing to the opposite party.
- e) Jurisdiction for legal disputes, if any, arising during the discrepancy of the contract shall be settled in Ahmednagar Court only.
- f) In case of any dispute arising with regard to this contract or its conclusion, the parties shall use their best efforts to settle such dispute amicably by mutual negotiations. In case no agreement is reached, the same shall be referred to the adjudication of sole arbitrator to be appointed by Rahuri Semen Station whose decision in the matter shall be final and binding on the parties, The arbitration proceedings shall be governed under the provisions of the Indian Arbitration & Conciliation Act, 1996 and the rules made there under. The venue of such arbitration shall be Ahmednagar and the courts at Ahmednagar alone shall have jurisdiction regarding any matter arising out of this contract.

- 2) The vehicles to be deployed should be neat & clean and in good running condition, along with driver, holding valid driving license and other relevant documents. For this purpose, the service provider shall ensure that the odometer of the supplied vehicle is properly sealed. - 6) The contract for providing vehicles will be given to the lowest bidder who fulfils all the terms and conditions given in the tender document. To safeguard against failure by the successful service provider in providing requisite number of vehicles, this office may empanel other service providers who are prepared/ready to provide services as per the same terms and conditions as that of L-I (Firm who has quoted lowest rates) tenderer.
- 7) On acceptance of the bid, the Service Provider has to submit Performance Security of an amount of Rs. 30,000/- of the entire period of the contract in the form of Fixed Deposit Receipt (FDR) or Bank Guarantee from a Commercial Bank in favor of NDDB DS Rahuri SS, Rahuri at the time of awarding the contract. - 17) In case vehicle does not report on time/does not report at all, the Rahuri Semen Station shall have a right to hire a vehicle from the market & the cost incurred shall be borne by the supplier. Additionally, where the supplier is unable to provide vehicles for any trip, a penalty of Rs.300.00 for scheduled trip may be imposed and debited to the supplier's account at the discretion of RAHURI SEMEN STATION based on the facts of the case. Any such penalty would be deducted by this from the particular trip bill without giving any prior notice.
- 18) Rahuri Semen Station shall have the exclusive right to cancel the contract at any time (by informing in writing) without assigning any reasons whatsoever and without any compensation to the supplier in case of breach of any of the terms and conditions of the contract. It should be ensured that there is no overwriting in the Trip Sheets.
- 26)In case of vehicle break down/servicing/repair, the supplier shall provide alternate vehicle of same/higher Make and Model (with the permission of RAHURI SEMEN STATION) failing which vehicle shall be hired from any other source(s) at the risk and cost of the Supplier. The drivers of the vehicles provided must follow traffic rules and other regulations prescribed by the Government from time to time. The Supplier shall assume full responsibility and bear the due liability under relevant sections of Motor Vehicle Act and IPC for causing death or permanent disability arising from vehicle supplied by the Supplier and Rahuri Semen Station will not entertain any claim in this regard under the provision of the law.
- 30) Engagement and employment of drivers and payment of wages to them as per existing provisions of various Labor laws and regulations is the sole responsibility of the Supplier and any breach of such laws or regulations shall be deemed to be breach of this contract.
- 31)The driver of the vehicle deployed for duty as per the requisition must have all relevant statutory documents like registration book/driving license/insurance policy /road tax receipt/permit fee/passenger tax/PUC certificate/Interstate permit. The vehicle should be licensed and shall conform to all Govt. rules and regulation being in force from time to time.
- 32) The bill in duplicate along with Trip Sheets duly signed by the user of the vehicle or his representative should be sent to Rahuri Semen Station for payment.
