Section 2 Instructions to Bidder

2.0 ELIGIBILITY AND QUALIFICATION BIDDER

- a. The bidder, in the same name and style, should be in business at-least for last 3 years at the time of bid opening. In case of change of name of the bidder by merger/acquisition/change in status, the bidder may be eligible based on the documentary evidence.
- b. The bidder should have valid registration under various Acts that may be applicable for the contract proposed. This shall include GST, PAN, etc.
- c. The bidder should have supplied similar category of items, having quantity more than the estimated quantity of works, against all purchase orders/ invoices including Rate Contracts executed during the last 3 years. Section 3.0 General terms & condition

3.1 Clarification of Bidding Documents

A prospective Bidder requiring any clarification of the Bidding Documents may notify the Purchaser in writing/fax/telex/email at the Purchaser's mailing address indicated in the Invitation for Bids. The Purchaser will respond in writing to any request for clarification of the Bidding Documents, which it receives not later than 7 days prior to the deadline for the submission of bids prescribed by the Purchaser. If required, written copies of the Purchaser's response (including an explanation of the query but without identifying the source of inquiry) will be uploaded in the websites mentioned.

3.2 Amendment of Bidding Documents

At any time prior to the deadline for the submission of bids, the purchaser may for any reason whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding document by the issuance of amendment.

The amendment will be uploaded on www.rahurisemenstation.com website. Before submission of the bid, the bidder should check the rahuri ss website for any Corrigendum/additional information on the bidding document, if any.

3.10 Contacting the Purchaser


3.11 Post Qualification

- a. In the absence of pre-qualification, the Purchaser will determine to its satisfaction whether the Bidder selected as having submitted the lowest evaluated responsive bid is qualified to satisfactorily perform the Contract.
- b. The determination will consider the Bidder's financial, technical and servicing capabilities. It will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, as well as such other information as the Purchaser deems necessary and appropriate including details of experience and records of past performance.
- c. An affirmative determination will be a prerequisite for award of the Contract to the Bidder. A negative determination will result in rejection of the Bidder's bid, in which event; the Purchaser will proceed to the

3.12 Award of Contract






