## Section 2 Instructions to Bidder

### 2.0 ELIGIBILITY AND QUALIFICATION BIDDER

- a. The bidder, in the same name and style, should be in business at-least for last 3 years at the time of bid opening. In case of change of name of the bidder by merger/acquisition/change in status, the bidder may be eligible based on the documentary evidence.
- b. The bidder should have valid registration under various Acts that may be applicable for the contract proposed. This shall include GST, PAN, etc.
- c. The bidder should have supplied similar category of items, having quantity more than the estimated quantity of works, against all purchase orders/ invoices including Rate Contracts executed during the last 3 years. **The bidder should submit the list of Purchase orders including Rate Contracts of similar category of items supplied/ executed in last 3 years.**
- d. Average Annual Turn-over of the firm during last 3 financial years should not be less than 30% of the estimated cost of the contract.
- e. Even though the bidder's meet the specified criteria, it may be disqualified if it has:
  - i. Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualification
  - ii. Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failure etc.
  - iii. If the bidder is overbooked beyond his capacity to execute the work as per required schedules.

## 2.1 Eligible Bidders

This invitation for Bids is open to all suppliers who have downloaded this bidding document in their name and meet the minimum eligibility criteria, if any, specified in this bidding document.

- c) It is hereby brought to the notice of all bidders that if any change/additions/ deletions/ alterations are found to be made by them in the tender and the same is subsequently noticed at any stage, even after award of the contract, the bidders are liable for all consequences thereof and NDS shall be free to take suitable action as deemed necessary.

## 2.7 Content of Bidding Documents

- i. The services required, bidding procedures and contract terms are prescribed in the Bidding Documents. In addition to the Invitation for Bids, the Bidding Documents include:
- (a) Instructions to Bidder;
  - (b) Statutory and Legal Conditions of Contract;
  - (c) Scope of work and terms & conditions;
  - (d) Price Schedule;
  - (e) Form of Bid;
  - (f) Deviation statement;
  - (g) Format of Bank Guarantee for performance security;
  - (h) Format of Undertaking;
  - (i) Bid securing declaration form;

- ii. The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information required by the Bidding Documents or submission of a bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk and may result in the rejection of its bid.

**2.8 Following KYC documents to be uploaded along with the tender bid:**

- Declaration with reference to PAN in case of individual/proprietorship (As per format shared in Vendor Registration Format).

- Copy of excise registration (if applicable)
- Copy of GST registration certificates in case vendor is registered, (A Declaration on letter-head required in case not registered for GSTN).
- Copy of MSME registration (Declaration required in case not registered.)

## **Section 3.0 General terms & condition**

### **3.1 Clarification of Bidding Documents**

A prospective Bidder requiring any clarification of the Bidding Documents may notify the Purchaser in writing/fax/telex/email at the Purchaser's mailing address indicated in the Invitation for Bids. The Purchaser will respond in writing to any request for clarification of the Bidding Documents, which it receives not later than 7 days prior to the deadline for the submission of bids prescribed by the Purchaser. If required, written copies of the Purchaser's response (including an explanation of the query but without identifying the source of inquiry) will be uploaded in the websites mentioned.

### **3.2 Amendment of Bidding Documents**

At any time prior to the deadline for the submission of bids, the purchaser may for any reason whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding document by the issuance of amendment.

The amendment will be uploaded on [www.rahurisenstation.com](http://www.rahurisenstation.com) website. Before submission of the bid, the bidder should check the rahuri ss website for any Corrigendum/additional information on the bidding document, if any.

However, non-information in changes/amendments put on website as Corrigendum to the prospective bidders shall not bind the purchaser to extend the deadline for the submission of the bids and non-compliance to such Corrigendum by the bidder shall result to non-responsiveness of the bid leading to rejection.

### **3.3 Preparation of Bid.**

The Bid prepared by the Bidder and all correspondence and documents relating to the bid exchanged by the Bidder and the Purchaser, shall be written in the English language.

### **3.4 Documents comprising the bid.**

The Bid prepared by the Bidder shall comprise the following documents:

- a. A complete description of the Goods/Services proposed to be supplied by the Bidder shall be uploaded on the NCDFI e-Market Portal. The Price Bid shall be submitted online in the prescribed format.
- b. Earnest Money Deposit in accordance with Clause No.3.7 (Section-02).
- c. Documentary evidence establishing bidder's eligibility and qualifications in accordance with Clause No. 2.8 (Section-02) and
- d. Documentary evidence establishing eligibility and conformity of services in accordance with Clause No. 2.14.
- e. A price schedule completed in all respect.
- f. Even though the applicants meet the above criteria, they are subject to be disqualified if they have:
  - i. Made untrue or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and or,
  - ii. Record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completion, or financial failures etc. (it should be part of evaluation)
  - iii. Notwithstanding anything stated above, the purchaser reserves the right to assess the Bidders capabilities and capacity to execute the contract satisfactorily before deciding on award.

Any exceptions the Bidder wishes to take in any aspect of the bidding document or payment schedule including a justification for the exception in the format furnished in Error! Reference source not found.

### **3.5 Bid Form**

- a. The Bidder shall duly fill, sign, and upload the Bid Form furnished in the Tender Document on the NCDFI e-Market Portal as part of the Technical Bid submission.
- b. All the required document duly signed/digitally signed should be uploaded on or before the specified date and time at NCDFI e market website.

### **3.6 Bid Submission:**

- i. Registration by vendors: All the vendors who wish to participate in the e-tendering process, are required to get themselves registered in the portal of the NCDFI E-market by providing & submitting necessary documents online.
- ii. Bidders shall submit their bids in two separate parts through the NCDFI E-Market Portal:
  - Part-I: Technical Bid.
  - Part-II: Price Bid.

The Technical Bid shall contain all documents required under the Tender Document except the Price Bid. The Price Bid shall be submitted only in the prescribed online format available on the portal.

- iii. All bid/ tender documents are to be uploaded online at E-market Portal i.e. <https://events.ncdfiemarket.com/> only and in the designated cover/ part on the website against tender ID. Tenders/ bids shall be accepted only through online mode and no manual submission of the same shall be entertained except tender fee and Bid Securing Declaration Form. Late tenders will not be accepted.
- iv. The Bidder shall ensure that no price information is disclosed in the Technical Bid. Any bid containing price information in the Technical Bid may be rejected.
- v. The Online bids shall be opened at NCDFI's E-market Portal, on above given date and time. If the tender opening date happens to be on a holiday or non- working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. NDDB Dairy Services, Rahuri Semen Station, Rahuri (MH) will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- vi. The bidder shall upload the tender documents/NIT duly filled in and stamped by the authorized signatory on each and every page along with all necessary Annexures as per NIT. Tender not uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection.
- vii. The original bid, both technical and Financial Bids shall contain no interlineations or overwriting, except as necessary to correct errors made by the Consultants themselves. The person who signed the proposal must initial such corrections. Submission

letters for both Technical and Financial bid should respectively be in the format of price schedule given at Section.

- viii. An authorized representative of the Consultants shall initial all pages of the original Technical ~~and Financial~~ bid. The authorization shall be in the form of a written power of attorney accompanying the Proposal or in any other form demonstrating that the representative has been dully authorized to sign.

**3.7 EARNEST MONEY DEPOSIT (EMD):**

Tenderer must submit EMD of Rs. 1,00,000/- (Rupees One Lakh only) in the format of e-payment irrespective of the items quoted i.e. schedule wise EMD amount as mentioned in the document will not be considered. Without EMD, the tender will be summarily rejected.

- ii) Payment of Earnest Money by cheque, T.D.R and F.D.R. will not be accepted.

- iii) Bidders shall be required to upload the successful transaction details along with technical bid.

- iii) **Late receipt of EMD:** Any EMD received by the Purchaser after the deadline for submission of bid prescribed by the Purchaser, then bid shall be rejected.

- iv) **Refund of EMD:** - The EMD of the bidders whose bids are not qualified/not acceptable will be refunded within 30 days after finalization of tender in the form of e-payment to those bidders who deposited EMD in the form of e payment, without any interest, upon receipt of a written request by the bidder after deducting bank charges, if any. Those who submitted EMD in the form of BGs, the same will be returned duly to the unsuccessful bidders. For successful bidders, EMD will be returned after submission of Security Deposit / PBG.

### **3.8 Modification and Withdrawal of Bids**

- a. The Bidder cannot modify or withdraw its bid after the bid's submission.
- b. No bid can be modified subsequent to the deadline for submission of bids.
- c. No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the Bidder on the Bid Form. Withdrawal of a bid during this interval may result in the forfeiture of Bidder's EMD.

### **3.9 Preliminary Evaluation**

- i. Technical Bids shall be opened online on the date and time specified in the Tender Document. The Purchaser will examine the technical bids to determine whether they are complete, responsive, whether required supporting documents have been furnished, and whether the bids are generally in order.
- ii. During the evaluation process, the Purchaser may seek clarifications and/or additional documents from the bidders, if considered necessary. The bidders shall furnish such clarifications/documents within the stipulated time.
- iii. The purchaser will also examine whether the bid is complete. If the prices of certain item is found as "0" ("ZERO") it will be presumed that the bidder has included the cost of these items against some other items of the price bid. The bidder shall furnish/upload the details of such inclusions separately.
- iv. If the Purchaser considers that with these omissions, the offered services is not functional, then the bid will be treated as incomplete and non-responsive.
- v. Only those bidders whose Technical Bids are found substantially responsive and acceptable shall be considered for opening of the Price Bids. The date and time & link of opening of the Price Bids shall be communicated to the technically qualified bidders through the ~~NCDPI E Market Portal~~ and/or email.
- vi. The Price Bids of technically qualified bidders shall be opened online and evaluated in accordance with the provisions of the Tender Document.
- vii. Arithmetical errors – Not Applicable.

- viii. The Bidder shall quote the rate for the complete scope of supply as specified in the Tender Document. Bids with a quoted rate of "0" (Zero), "Nil", or no quoted rate shall be treated as non-responsive and shall be rejected.
- ix. The Purchaser will evaluate and compare the bids previously determined to be substantially responsive, No bid will be considered if the complete requirement covered under the scope of work is not included in the bid. The unit price quoted should be after considering the discount, if any.
- x. The evaluation and comparison of bids will be done on the basis of quoted prices inclusive of applicable taxes and duties as mentioned in price schedule.
- xi. **Evaluation of Quotation:** The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which GST, Packing, Forwarding, Freight & Insurance charges in connection with sale of goods shall be taken into account in evaluation.

### **3.10 Contacting the Purchaser:**

- a. Bidder shall contact the Purchaser on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded.
- b. Any effort by a Bidder to influence the Purchaser in the Purchaser's bid evaluation, bid comparison or contract award decisions may result in the rejection of the Bidder's bid.

### **3.11 Post Qualification:**

- a. In the absence of pre-qualification, the Purchaser will determine to its satisfaction whether the Bidder selected as having submitted the lowest evaluated responsive bid is qualified to satisfactorily perform the Contract.
- b. The determination will consider the Bidder's financial, technical and servicing capabilities. It will be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, as well as such other information as the Purchaser deems necessary and appropriate including details of experience and records of past performance.
- c. An affirmative determination will be a prerequisite for award of the Contract to the Bidder. A negative determination will result in rejection

of the Bidder's bid, in which event; the Purchaser will proceed to the next lowest evaluated bid to make a similar determination of that Bidder's capabilities to perform satisfactorily.

### **3.12 Award of Contract**

- i) Purchaser will award the contract to the successful bidder whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid provided further the bidder is determined to be qualified to perform the contract satisfactorily.
- ii) NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station may at its discretion to award the contract to one or more Suppliers at varying rates and/or for the combination of the category of any destinations. NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station reserves the right to enter into ad- hoc/parallel rate contract simultaneously or at any time during the period of contract with one or more Suppliers.

### **3.13 Purchasers Right to Vary Quantities at the Time of Award:**

The Purchaser reserves the right to vary the quantities at the time of award of the contract, if the need arises in consultation with the successful bidder.

### **3.14 Purchaser's Right to Accept Any Bid and to Reject Any or All Bids:**

NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station does not bind itself to accept the lowest bid. NDDB DS Rahuri SS reserves the right to award the job either in part or full. NDDB DS Rahuri SS at its sole discretion and without assigning any reason thereof, also reserves the right to accept any/or reject any or all bids.

NDDB Dairy Services also reserves the right to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the Purchaser's action.

### **3.15 Notification of Award:**

- a. Prior to expiration of the period of bid validity, the Purchaser will notify the successful Bidder in writing by registered letter/courier/by cable/telex/fax/e-mail, to be confirmed in writing by registered letter/courier/e-mail, that its bid has been accepted.
- b. The notification of award will constitute the formation of the Contract.

- c. Upon the successful Bidder's furnishing of performance security, the Purchaser will discharge the EMD of unsuccessful bidders.

### **3.16 Signing of Contract:**

- a. As the Purchaser notifies the successful Bidder that its bid has been accepted, the bidder is requested to submit the "Undertaking" as provided in the Bidding Document, incorporating all agreements between the parties.
- b. Successful bidder needs to sign the Agreement (format given in section 12.)
- c. The "Undertaking" and "Acceptance" copy of the contract" shall be returned within 15 days from the date of contract.

### **3.17 Performance Security**

Within 30 days of the receipt of notification of award from the Purchaser, the successful Bidder shall furnish Security Deposit of Rs. 1,00,000/- through NEFT/FDR OR Bank Guarantee in accordance with the Conditions of Contract, in the Performance Security Form provided in the Bidding Documents or another form acceptable to the Purchaser. Bank guarantee issued only by Nationalized/Scheduled commercial Banks/Foreign banks having branches in India will be accepted.

### **3.18 Bid Form**

- a. The Bidder shall complete the Bid Form (Format given as Section 7) furnished in the Bidding Documents and provided the same along with technical bid.
- b. All the required document duly sealed & signed should be uploaded before the specified date and time at NCDFI E-market portal.

### **3.19 Termination of contract:**

- a. During the term of this contract, NDDB Dairy Services NDDB Dairy Services, Rahuri Semen Station reserves its right to terminate this contract by giving 30 (Thirty) days' notice without assigning any reason thereof.
- b. NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station the exclusive right to suspend, cancel, and terminate this contract at any time if it has sufficient reasons to believe that the Contractor has

failed to perform or observe or fulfil any of the terms and conditions herein before contained and/or liable and responsible for any loss or damage suffered by the NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station Rahuri (office).

- c. The NDDB Dairy Services, NDDB Dairy Services, Rahuri Semen Station shall have the right to ask of the removal of any person, if one is not considered to be competent and orderly in the discharge of his duties.

### 3.20 Termination for Convenience

- a. The Purchaser, by notice sent to the Supplier, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.

- b. The Goods that are complete and ready for shipment within twenty- eight (28) days after the date of issuance of the termination notice, shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect:

to have any portion completed and delivered at the Contract terms and prices; and/or to cancel the remainder and pay to the Supplier an agreed amount for partially completed Goods and Related Services and for materials and parts previously procured by the Supplier.

### 3.21 Liquidated Damages (LD):

If the bidder fails to deliver any or all the goods or perform the services within the time period(s) specified in the purchase order/contract, the NDDB DAIRY SERVICES, RAHURI SEMEN STATION shall, without prejudice to its other remedies under the purchase order/contract, deduct from the purchase order/contract price, as liquidated damages, a sum equivalent to ~~(A) 0.5% of Full Contract Value for each completed week of delay~~

Repeated failure to supply LN<sub>2</sub> as per the Contract may result in termination of the Contract and forfeiture of the Performance Security Deposit, without prejudice to any other rights available to NDDB Dairy Services, Rahuri Semen Station under the Contract.

### 3.23 Force Majeure

The terms and conditions mutually agreed upon shall be subject to Force Majeure Clause. Neither party shall be considered in default in performance of their obligations here under if such performance is prevented or delayed because of war, hostilities, revolution, civil commotion, strike, epidemic, accident, fire, wind, flood, earthquake or because of law and order proclamation, regulation or ordinance of any Government or of any act of GOD or any other clause whether of similar or dissimilar nature, beyond the reasonable control of the party affected. Should one or both the parties be prevented from fulfilling their obligations by a state of Force Majeure lasting continuously for a period of six months, the two parties should consult each other regarding the future implementation of the contract.

### 3.24 Taxes, duties and levies:

All taxes, duties, levies etc. imposed by the Central / state Government in connection with this contract in force at the time of submission of BIDs shall be borne by the Contractor during currency of contract. The taxes deemed to have included in the price bid; however, GST shall be payable as applicable.

### **3.25 Period of contract**

### **3.26 Completion of contract**

### **3.28 Insurance:**

Purchaser shall be at liberty to purchase the quantity of items rejected from other parties without giving any notice and at supplier's risk & cost and recover the additional expenditure, if any, from any of the outstanding dues of the supplier/ contractor. Purchaser shall be entitled to recover the expenses made by Purchaser on storage and handling of such rejected goods till the goods are removed from purchaser's premises/ stores.

### **3.30 Inspection:**

On placement of order, the equipment under the purview of supply should be inspected by the supplier's own technical experts at the supplier's works and such inspection report should be forwarded to Purchaser in triplicate. However, Purchaser reserves its right to inspect at any stage of fabrication/manufacture of the equipment/material. The supplier should intimate the Purchaser without fail, when the equipment is ready for inspection including the stage wise inspection. The supplier should not proceed with further manufacture and/or dispatch of equipment, without obtaining a clearance certificate from Purchaser. The supplier should forward to Purchaser the Test Certificates, wherever applicable, obtained from concerned authorities/ principal manufacturers either regarding quality or any other details of the items utilized in the process of manufacture/fabrication.

### **3.31 Dispatch Instructions:**

The materials are to be dispatched to the destination by the mode of transport specified in order under intimation to Purchaser. Depending on the type of material, the supplier shall have to carry out proper packing/ crating to avoid breakages in transit. Other details of dispatch such as consignee's particulars etc. are mentioned in the purchase order. For using any mode of transport other than the specified one, prior concurrence from Purchaser in writing should be obtained. All consignments should be dispatched on freight paid basis irrespective of price basis. In the event of freight payable extra by Purchaser, the supplier shall have to obtain purchaser's prior approval and produce necessary documentary evidence in support of claims. ### **3.32 Arbitration**
